Air Force Security Forces Association Eagle Chapter Sig Sauer Pistol Raffle Official Rules

Purchase of a ticket is required to enter and win this raffle.

The AFSFA Eagle Chapter Raffle (raffle) begins at 9:00 AM Eastern Standard Time Daylight Time (EDT) on July 20, 2017 and ends at 11:59 PM on October 10, 2017.

ELIGIBILITY: Open only to legal residents of the United States and Washington D.C., age 21 years or older. Subject to all applicable federal and state and local laws and regulations. Void where prohibited by law. Governed by U.S. law. The Eagle Chapter Chairman/Chief Executive Officer, the chapter board of officers, the Third Party Program Manager, the Air Force Security Forces Association (AFSFA) Executive Director, AFSFA Board of Officers, appointees, and their immediate families (parents, children, spouse, siblings), and those living in the same household (whether related or not) are not eligible to win.
