Eagle Sponsors 4 SF Teams and Provides Defensor Fortis Flags for Rucks




It was our pleasure again to help with the 436th SFS' 17th Annual Ruck March to commemorate the Korean War Battle of Chosin



NLEOM to Reopen Cases Involving Denied SF Airmen



During Police Week, Eagle Chapter's yellow rose tribute SF Airmen who have died while performing police duties in combat but are not recognized by the National Law Enforcement Officers Memorial

In December 2015, following the deaths of Tech Sgt Lemm and Staff Sergeant Bonacasa in Afghanistan, I began a discussion with the National Law Enforcement Officer Memorial (NLEOM) staff to discuss their policy regarding military police who die while performing police duties in combat. Though this was not an issue for the two Airmen who were killed in December because Afghanistan is no longer considered a combat zone, the death of these two Airmen was a painful reminder to me of work not yet finished to have our SF KIAs memorialized at the National Law Enforcement Officers Memorial

Last week, the NLEOM informed me that they would reopen their records and review the decision of their board that denied General Hertog's Nov 2008 request to recognize the seven airmen (Jacobson, Norton, McElroy, Chavis, Nathan, Self, and Griffin). The intent is to not purely look at the policy but the activities of these Airmen when they died.

At the end of their review, they will provide me the results and discuss next steps. I have invited the USAF SF to join in this discussion when NLEOM has conducted their review as they are in a much better position to take next steps needed should the review result in our Airmen being recognized. This just might be our year!
